Expansion project Airport-to-Airport Pharma Corridor

The current Airport-to-Airport Pharma Corridor project, has triggered a lot of interest by different other airport members of Pharma.Aero to start up more Pharma Airport-to-Airport corridors. In the upcoming weeks, Pharma.Aero will call to the membership in order to multiply and develop more Airport-to-Airport corridors as an expansion of the first project.

The Airport Transport Benchmark Study

This project was one of the very first projects to be launched by Pharma.Aero, and is now being finalized. In order to be able to do so and finally present a technical report and white paper, Pharma.Aero re-launched the project recently. The final gaps will be closed and especially the listing of good practices by different airport members will be added into the final steps of the project.

Security Project

This project is about to be launched with the aim to compare the most relevant available Security Programs as per areas of concern (Aviation Security, Custom Security and Asset Protection Security). The results will be compared to IATA's Pharma CEIV standard and requirements giving evidence of gaps and overlaps. The planned final project goals will lead to a definition of a harmonization security, a definition of guidelines for identification of security critical points for Pharma products in the air cargo supply chain and proper critical points mitigation and a definition of guidelines for harmonization of the Pharma and Security processes.

Updated member communication.



We will start creating regular membership group calls (3 calls a month, each per membership type) to facilitate and allow each member to share important news/interesting evolutions in the industry (incl. Pharma.Aero), suggestions for Pharma.Aero e.g. its BOD, website, back office, communication, projects (on-going and potential new ones) etc. A short report will be written of these calls to be used in different communication channels (newsletters, website, LinkedIn).

If a member hasn't joined after 3 calls, we will invite them for an individual call.
