Pharma.Aero Exceptional General Assembly and Voting Results

On 29 April 2020, Pharma.Aero held its virtual Exceptional General Assembly. During the virtual meeting, our Strategic and Full Members were briefed on the following voting topics:

- Voting on the new Statutes
- Voting on the new Internal Regulations
- Voting on the new Board of Directors
- Voting on the Financial Budget (both past and future allocations)

A voting poll was sent out immediately after the call to the Strategic Members via Survey Monkey. The votes were received within 24 hours and we reached the voting quorum. The outcome of the voting is:

- The new Statutes have been agreed on and are effective as of April 29, 2020
- The new Internal Regulations have been agreed on and are effective as of April 29, 2020
- The new Board of Directors is in place as of April 29, 2020
- The past financial budget (October 2019 March 2020) has been agreed on
- The future allocated budget (Budget 2020) has been agreed on
